### **Preparation For On Road Driving**

The METEC Pre-Learner Training Course provides this professional "Start to their driving". The course is a total of 14.5 hours, run over two 6 hour days and a night session of 2.5hours.

During this course, participants are taught to drive on our "off road" complex at Kilsyth. Instructors are fully qualified and experienced and teach in manual, dual controlled cars. The METEC complex has a variety of roads with hills, three point turn areas, slalom areas etc.

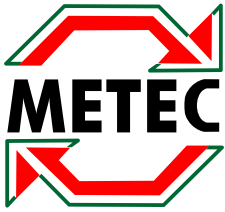
The course also includes theory sessions covering the following:

- Correct driving techniques, with emphasis on Defensive Driving
- Driver attitude
- Basic mechanics
- Effects of drugs and alcohol
- Road law
- Importance of tyres

The course is held on weekends during school term and on week days during school holidays. Bookings are essential and cannot be confirmed until payment is made in full.

Learner Permits are not essential to participate in this course, in fact, if not held, we recommend that the course be completed first as it is most informative and assists with knowledge for the Learner Permit Test.

METEC is accredited VIC ROADS Learner Permit Test Centre and can also provide on-going professional training right through to licence.

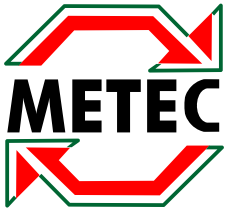
